### How I Found My Way to Recovery

always chuckle when reading *Chapter Four, We Agnostics*, out of the *Big Book* and I get to the part that reads, "To be doomed to an alcoholic death or to live on a spiritual basis are not always easy alternatives to face." The first time I read that passage I thought this was bit melodramatic, and a knucklehead like me had to actually ponder this dilemma of options as an extremely difficult choice! I came into the rooms of Alcoholics Anonymous as my last choice or option to quit drinking. The only thing I wanted was for all of you fine people to show me how to quit drinking, then life would be easy, and I would be on my merry way out of AA with a tip of the hat to you all and wishing you the best for the rest of your lives. The recollection of my arrogantly ignorant motives I brought with me as I joined this fellowship stirs that slightly dark, tragic humor that only resonates with another alcoholic in recovery.

I got sober in Norfolk, VA by way of the rooms of Alcoholics Anonymous in June 2012. Fortunately, I had been blessed with the gift of pain and desperation which cracked the door open to actually be willing to do anything my sponsor suggested at the time. My first homegroup, The Simple Actions Group, started in the living room of David F's home. With a message focused on the solution, this group grew tenfold in mere weeks and found a nearby church with plenty of meeting space. As the group grew, it brought about the need for elections and appointments for its own service positions. During my first homegroup business meeting, the chairperson was looking for volunteers for each homegroup service position. The position of Intergroup Representative was brought up, and my sponsor immediately nominated me for this position with a slight smirk from the corner of his mouth. The chairperson stared at me and eventually asked if I was willing to accept the nomination, and my response was a frightened mumble that said . . . "What is Intergroup?" After a generous laugh by all in attendance, they said "That is the perfect response! It makes you even more qualified to be Intergroup Rep for the homegroup. John M. is our new Intergroup Rep!"

I was confused by the group's response but got the impression that my lack of knowledge was going to be okay. My first meeting at the Tidewater Intergroup was one heck of an experience. There were almost 150 people in attendance representing homegroups from Virginia Beach to Williamsburg. I witnessed a 40-minute debate over how to responsibly spend \$1.75 with people speaking loudly and referencing things like the Twelve Traditions and our primary purpose. My initial reaction was filled with awe, a little bit of irritability about the length of the meeting, and how intensely serious people's feelings and statements were about \$1.75.

I shared the experience with my homegroup along with my highly unnecessary opinion that it seemed like an unproductive investment of time and energy.

It was explained to me that, while I may not come to share the same passion as others in AA regarding our service and operational structure, I should be grateful for those who are that passionate and keep AA operating and moving forward to help anyone who has a desire to stop drinking.

In thinking back, I made it to my first AA meeting because I called my sister, while completely hammered in the middle of the night, to tell her I couldn't stop drinking and needed her help. She drove two hours and was there the next morning. Having no experience with AA herself, she simply Googled "AA in Norfolk." Within seconds a recovered alcoholic answered the phone and calmly educated my sister on how the program works, and where the closest meeting was to us in the next 30 minutes. He suggested that it may be a good idea to head to the meeting immediately as alcoholics are capable of a sudden change of mind at any moment. It took me a year or so to come to the realization that it was Intergroup that had arranged for someone to answer the phone that day . . . it was Intergroup that had all of the meetings posted online . . . it was Intergroup that bulk purchases the literature for the groups it serves which in turn distribute the Big Book that was given to me by my first sponsor . . . and Intergroup's service as a resource played an active role in helping to carry the message to a knucklehead like me.

As I've been fortunate to stick around this program for a number of days, months, and years; that attitude of "show me how to quit drinking so I can graduate and move on with my life to do other things" has faded away. It has been replaced based on having had that "Spiritual Experience" as the result of going through the steps. All of the promises we read have absolutely come true for me, regardless of the fact that I had not really been interested in seeking them. Virtually every valuable component of my life today is the direct result of this program. A progam that was established by, continuously operated, and grown by alcoholics com-

mitted to this solution for decades before me.

However, none of this changes the fact that I am an alcoholic, and I really need to be doing all of these simple actions suggested by our program on a daily basis. It is amazing how quickly I can forget how I got the life I have today. These gifts of sobriety combined with my ego have lead this alcoholic to trouble on more occasions than I care to admit. I have suffered from focusing more time on my hobbies, my career, and personal relationships than my higher power and this program that got me here. When this happens, my AA life and the daily, simple actions can rapidly decrease or even vanish. Fortunately, I also benefit/ suffer from great sponsorship. My current sponsor loves to remind me that "he, nor anyone he knows, has never gotten hurt by doing too much AA." He shares this all the time when he sees my floundering from inaction. When I'm looking for reasons and justifications to leak away, I have continuously found that my service commitments at Richmond Intergroup and the act of sponsoring other men have kept me attached enough to never fully leak away from the program that saved my life.

I have found it inspirational to learn how other folks have been introduced to this program. There are those who were introduced by meetings brought into prisons, others through treatment centers, and many, like me, who found their way to this fellowship through their local Intergroup whether they realized it or not.

Serving in Richmond Intergroup as a homegroup representative, chair of the audit committee, and now as Secretary and Steering Committee member has been a critical experience in my recovery. It was not something that I sought out but, instead, was guided to the action and service by following the message of amazing alcoholics and their experiences in these rooms. Not every Intergroup meeting or email is exactly what I want to do at that moment, but it has certainly kept me humble, grounded, and in contact and service with others when I needed it most so I can keep trudging the road to happy destiny with my fellow alcoholics. #

### The History of 210 North Madison Street Group

"210" North Madison Street Group of Alcoholics Anonymous" came into being in October 1953 when a local couple deeded the building to the group's trustees for the princely sum of \$10.00 on October 5, 1953.

Prior to that, some 250 Richmond A.A. members had been meeting at 203 North Jefferson St. as the Richmond Group of Alcoholics Anonymous. Since they were faced with overcrowding and a probable rent increase there, the gift of the building offered a perfect solution. Looking like a "bunch of vaga-

bonds" (according to one observer) they happily lugged their furniture one block through an alley to their new home.

The first order of business for the renamed group in its new home was to clean up and decorate in preparation for the celebration of its June 20, 1954 grand opening, held in conjunction with the nineteenth anniversary of Alcoholics Anonymous which began on June 10, 1935.

Soon after, 210 had become the hub of the Richmond A.A. universe and by 1961 hosted four of the eight

weekly meetings in town. With its Saturday night dances (over 300 at the 1958 New Years Eve Dance) it negated the need for a separate social club chartered in 1948 at 920A W. Broad St. Between 1960 and 1972 it also hosted 19 Virginia Area Committee Meetings.

Over its 60+ years 210 has provided a vital haven for both locals and travelers in recovery. Its membership roster from the mid-fifties through 1965 lists over 2,000 member names, and, until December 1982, it was Richmond's AA "office." #


